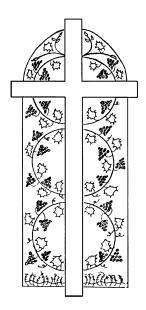

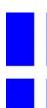

# OutReaching Together

With the help of Eagle Scout Team 78, we participated in the Souperbowl of Caring in January, and our former deacon Susan Lindberg Haley delivered 12 handmade throw blankets to Children's Hospital in early April.

In May, we participated in Family Promise's annual walkathon, and agreed to donate \$500 to ProGente Connections to help them make it through a difficult quarter.

A "two-fer" food drive for Pearl St. Cupboard and A Place To Turn took place on October 16, and longtime member Chris Llorant led a voter registration event on October 23rd.

In November, the Outreach team used budget funds to provide 40 grocery store gift cards to Wayside Family Services. Each gift card was enclosed in a handmade Thanksgiving card, made during several coffee hours in late October and early November. While 40 cards represented a decrease from prior years due to the loss of the LCF funding contribution, Wayside remains grateful for our continued support.

The Giving Tree was a success! This year we fulfilled 96 different requests from SMOC, the Callahan Senior Center, and Veterans' Associations in Marlborough and Framingham. Additionally, we provided \$150 dollars to SMOC. Thanks to everyone who grabbed an ornament (or two or three!) from the tree. Much Christmas joy was spread throughout MetroWest.

We hope to expand our activities in the year to come. Keep an eye out for announcements in the weekly church emails and consider joining our email list!

# **Properties Ministry**

The Properties Ministry is responsible for the cleaning, periodic maintenance, repairs and upgrades of the church building and grounds.

In the past year we have replaced the gutters and installed sandbags around window wells where necessary, to reduce water ingress to the basement. As an Eagle Scout Project, a seating area was created next to the main entrance ramp. We evaluated rekeying the interior doors but decided not to, based on the cost. This year, in partnership with the Scouts we will perform a survey of the interior locks and keys. As part of the Capital Campaign, some of the pews in the Sanctuary have been modified to provide wheelchair seating.

We have started the process of renovating the Memorial Room. The design is mostly set, and we expect to do the work this summer. We plan to perform some of the work ourselves and will be looking for volunteers to help. We are in the early stages of redoing the landscaping around the main entrance ramp and parking area.

# Senior Warden's Report

This past year was a year of change at St. Andrew's. We began to transition out of the height of the pandemic with a return to in-person worship and resumption of coffee hour after church. Starting with a Valentine's outdoor hot cocoa hour, we found creative ways to begin bringing people together for the socialization they may have missed over the past two years. By March we were able to gather in Harris Hall to celebrate Julie Carson's 15 years as rector with a special luncheon. At the same time, we were preparing to wind down our partnership with the Lutheran Church of Framingham and say goodbye to Deacon Susan Lindberg- Haley. On May 1, we shared a final service with LCF and celebrated them and our partnership. Shortly after the dissolution of LCF, Julie announced her plans to resign and her call to another parish as an Interim Priest. The transition happened quickly with her wrapping things up, luncheon to celebrate her ministry and say goodbye and then calling on supply Priests to preside over Sunday worship. We were fortunate to have had seven parishioners complete the training to lead a morning prayer service and utilized them on weeks when there was no clergy available. Next, we went through the process of finding an Interim Priest and were thrilled to have Pastor Sue Sprowls join us in Advent. More change will happen down the road as we begin the process of forming a search committee who will be charged with seeking a new permanent rector.

All these changes are enough to make one's head spin. How they were all handled is a testament to the congregation's strength, flexibility, persistence, and faith. Change can challenge us, make us question and defeat us, but it can also make us stronger and resilient. Members of the church rose to the occasion and offered their talents more than before- as lay leaders of the service, as worship leaders, as musicians, as fundraisers, as technicians, as outreachers, as financial and building stewards, as greeters, and as organizers. You all are what makes St. Andrew's church a home and I am grateful for all of you, especially during this time of change. Thank you!

As detailed in the table above, the average pledge has increased to \$2876, or an average increase of 6.72%. This is a testament to the generosity and commitment of our congregation. We have 69 pledging units this year. Perhaps most encouraging is that we have 12 pledging families or individuals who are either new pledgers or did not pledge last year.

The amount pledged will go a long way to funding the church. However, it is important to note that this amount will still result in a significant draw from our endowment. The vestry is committed to being good stewards of the resources entrusted to us, and we will work to ensure that our financial decisions are made with care and thoughtfulness.

Going forward we will explore ways to pledge via the livestream, revamp the donation page on the website, and speak more frequently through the year about stewardship and pledging progress.

I want to take this opportunity to thank each and every one of you who has pledged to support St. Andrew's financially this year. I understand that this has been a challenging year, and I am grateful for your willingness to continue giving.

# St. Andrew's Church Treasurer's Report Annual Meeting

February 5, 2023

### **Overview**

In short, the parish is in a very firm financial position in terms of assets with few liabilities. Due to several non-recurring events, our draw on our endowment was well below budget.

Some of the major events affecting our finances are noted here, with details further below.

- Our rector of 15 years, Julie Carson moved on. Her departure left a large void in our parish life which we have work diligently to fill. Since we functioned without a rector for 3 months, we did benefit from not paying a rector's salary.
- We called an interim rector, Susan Sprowls, in December. We incurred responsibility for moving expenses, some of which were charged in 2022.
- Despite the pandemic, our parishioners continued in their generosity, exceeding our budgeted income.

This report is organized in 3 sections.

- 1. The narrative (this section). The analysis of the following sections is contained here.
- 2. The Income Statement. This section shows income and expense incurred during in the years 2019 to 2021. It also shows the 2021 and 2022 budgets as approved by the Vestry.
  - For brevity and clarity, I omitted some lines with low activity and low interest. The lines representing totals and subtotals show the correct, full amounts, including the values from the omitted lines. - 3. Balance Sheet. This is the 10,000 foot snapshot of our financial health, comparing the end of the past 2 years.

### **Reviewing 2022**

### **Income Statement**

#### 2022 OPERATING INCOME

**4002 Endowment Income:** This is our draw from the Endowment. The dramatic underuse (compared to budget) of our endowment is welcome, but we can't expect to repeat it.

Some of the contributors to 2022's low endowment use are: lack of a rector for 3 months, Employee Retention Credit payments, higher than expected donations, higher rental income, no DCE on salary and general lower expenses.

Pledges Current Year Pledge income has increased in 2022.

**4305 Rental Income** Rental income has rebounded from the pandemic years.

**4305.1 Allocated to Maint.:** This is the rental offset. This is listed this way to make for easier reporting on the Parochial Report. There is a balancing amount on the expense side, thus the net income is unaffected.

#### 2022 NON-OPERATING INCOME

- **6218 Capital Campaign:** The income from the capital campaign is winding down. It was intended to be done at the end of 2021.
- **6700 Long-term investment gains (losses):** The good times ended in 2022. In 2022 we lost most of the gains in 2021. I'm confident that the market will recover, but not immediately. We will need patience.

#### **2022 OPERATING EXPENSE**

Several expenses varied from the budget. Items worth noting:

- **Total 5000 Salaries:** Salaries were below budget due to the resignation of Julie. Also, the DCE position remains open.
- **5300.1 Rental offset:** The negative entry is the amount attributable to renter costs. There is an equal negative entry in rental income offsetting that amount of rent income.

A functional classification of expenses offers a very brief view of where our expenses are allocated.

#### **NET OPERATING INCOME**

The Net Income is precisely zero because the draw from the endowment is adjusted to balance income and expense.

### 2022 Budget

#### 2022 BUDGETED INCOME

**4000 Investment Income** This amount (\$116.9k) is selected to balance the budget. The Vestry is aware that this level of dependence on the endowment is not sustainable.

To repeat, this level of Endowment draw is not sustainable. If this level is continued, we can expect to deplete the Endowment within 20 years. One mitigating fact is that we have been actually drawing less from Endowment than budgeted. This positive habit is not predictable, and is due to two facts:

- We have a number of regular givers who do not pledge. Without pledging, it is difficult to budget income accurately. Additionally, some pledgers donated more than they pledged.
- We have some open positions that should be filled for the good of parish life (and growth!). We had budgeted for these positions, so our actual expenses have been lower than budgeted.

#### **2022 BUDGETED EXPENSE**

**5000 Salaries:** We budgeted for a 12 months of rector salary and 6 months of DCE salary in the hopes that we will hire a DCE.

**5710 Maintenance Fund:** We are not supporting the maintenance fund in 2023.

**Long Term Investments** We moved all our investments to the Diocesan Investment Trust.

**Total Bank Accounts** Our cash on hand is comfortably sufficient to support normal operations, including the Endowment draw, without needing to draw cash from investments.

**Acolyte Fundraising** We are holding funds for new acolyte robes, donated by LCF.
